

Managing In-Class Behaviour

Classroom Behaviour System

Sanction	Description	Student Action	Communication	Recording/Sanction	Failure to comply with sanction
Verbal Reminder	A verbal reminder is given to the student about classroom behaviour expectations	Student makes every effort to regain focus and attempts to meet expectations.	Staff member clearly communicates the behaviour expectation the student needs to correct.	No recording of sanction required.	Escalated to 1st Warning
1st Warning	A student fails to respond positively to the verbal reminder and is then sanctioned with a 1st Warning.	Student may be asked to move seats. Student may be required to have a reset conversation outside of the classroom	Staff member clearly states the reason for the first warning. Staff member records the verbal warning on Edulink with a notification of Verbal Warning sent to Parents.	Teacher records 1st Warning on Edulink. Edulink sends a notification to the parent. No detention is set for this sanction. 0 behaviour points are assigned to a 1st Warning.	Escalated to 2nd Warning
2nd Warning	A student fails to respond positively to the 1st Warning and continues to demonstrate behaviours which do not meet the teacher's expectations.	Student may be asked to move seats. Student may be required for a reset conversation outside of the classroom. Student attends a break detention.	Staff member clearly states the reason for the second warning. Staff member records the warning on Edulink with a notification of 2nd Warning sent to Parents.	Teacher records 2nd Warning on Edulink. This incident has a value of 2 Behaviour Points with a break detention set.	Escalated to Removal
Removed to Receiver	A student has persistently disrupted the lesson following a 2nd warning Or A one off incident requiring removal from lesson.	Student stands outside the classroom and awaits On Call. Student taken to Receiver Room. A Reflection Document is completed and returned to the original teacher at the end of the lesson.	Staff member clearly communicates the reason for removal from the lesson. On Call is requested via Edulink App or Radio. Incident recorded on Edulink . Notification of incident sent home. Phone Call from teacher.	Teacher records removal on Edulink. This incident has a value of 5 Behaviour Points with a lunch detention set.	Escalated to Failed Receiver
Failed Receiver	A student has disrupted the learning of students in the Receiver Room. Or A student has failed to follow the request to go to a Receiver Room.	Student is required to follow instructions given by On Call and go to the Isolation Room for the remainder of the lesson.	Staff member clearly communicates reasons for the breakdown of the receiver room. On Call clearly communicates a request to attend Isolation. Full day Isolation placement is booked through DMI or TMO. Phone call home from Learning Manager	Student attends Isolation for the remainder of that lesson. Isolation Placement booked for the following day. Sanction recorded on Edulink. Sanction Value is 10 Points.	Isolation Placement
